

IBEX 40 Year Limited Warranty

Applicable to WeatherXL Products and Dura Coat Ceranamel XT-40S Products Only

IBEX Metal, LLC (herein referred to as "IBEX" or "IBEX Metal") provides the following warranty concerning the use IBEX's metal building panels and accessories.

IBEX warrants that our products will not, under normal atmospheric conditions, in the Continental United States, Alaska, and Canada:

- A) Crack, Check, or Peel for a period of (40) forty years from date of installation (except for such crazing that may occur on tightly roll-formed edges and brake bends.)
- B) Chalk in excess of a numerical rating of (8) for a period of (30) thirty years from date of purchase when measured in accordance with the standard procedures outlined in ASTM D-4214 on vertical (sidewall) surfaces. On horizontal application (roofing), chalk will not exceed a-numerical rating of (6).
- C) Fade or change color in excess of (5) E units (NBS) for vertical (sidewall) surfaces and seven (7) for non-vertical (roof) surfaces, for a period of (30) thirty years from date of purchase as calculated in accordance with ASTM D-2244, Paragraph 6.3. Color change is to be measured on an exposed painted surface that has been cleaned of surface soils and oxidation, and the corresponding values measured on the original or unexposed painted surface. It is understood that fading or color changes may not be uniform if the surfaces are not equally exposed to the sun and elements.

THIS WARRANTY IS SUBJECT TO THE FOLLOWING CONDITIONS:

- This warranty is restricted to failures resulting from normal weathering and does not
 include coating failures caused by scratches, scrapes or any other unnatural damage.
 IBEX Metal accepts no liability for damages caused by acts of God, radiation, falling
 objects, explosions, or other external forces beyond IBEX's control. This warranty does
 not cover any kind of substrate corrosion, including corrosion at the cut edges of a
 building panel.
- 2. IBEX Metal does not accept damage to the coating occasioned by moisture or other contamination detrimental to the coating attributable to improper storage prior to

- purchase, damage to the coating occasioned by condensation attributable to improper packaging, handling, shipping, processing and or installation.
- 3. This warranty excludes failures caused by standing water, and direct exposure to corrosive and aggressive atmospheres including animal waste products.
- 4. This warranty does not cover failure due to salt spray corrosion.
- 5. IBEX Metal's responsibility liability is limited and extends only to the direct cost of refinishing or replacing failed coated substrate and in no event shall IBEX Metal's liability exceed the original unit price of the coated metal panels, trim, and flashing. IBEX Metal cannot accept liability for loss or damage to other property or equipment, loss of profits or sales, or any other claims relative to standard business interruption, or any other incidental or consequential damages. This warranty does not cover, nor does IBEX Metal accept any financial responsibility for tear down, removal or reinstallation of solar panels, or any other attachments previously added to the roof or its surface.
- 6. IBEX Metal reserves the right to establish whether repainting or replacing material is required and to approve and participate in the negotiation of any subcontracted material replacement, installation, or re-finishing. After replacement or re-finishing, the repaired area will be considered installed as the original project installation date for the purpose of the application of this warranty. This warranty will be in effect for the remainder of the warranty period applicable to the metal originally coated.
- 7. Claims under this warranty must be submitted in writing within forty-five (45) days of discovery of the warranted performance failure. Upon review, IBEX Metal may, at its discretion, choose to remediate said claim under the terms and conditions outlined in the warranty document or inspect the project. IBEX Metal requires the opportunity for site failure inspection and investigation. IBEX Metal also reserves the right to solely evaluate and determine its obligation under the terms and conditions of this limited warranty.
- 8. This limited warranty supersedes any and all other warranties of performance, expressed or implied, by IBEX Metal. Any modifications, additions, or adjustments made to this warranty must be officially added as a signed written amendment.

ADDITIONAL EXCLUSIONS

- 1. Significant differences in insulation below the coated metal panel
- 2. Mishandling by Buyer of any metal panels or trim, including abuse, alteration, modification, improper use, or storage thereof, and
- 3. Attachment or adhesion of material or items such as snow guards and solar panels to the coating.
